Another beneficial feature of 3M Mark Remover 8001 is its antistatic capability. 3M laboratory tests have shown it to be an excellent topical antistat, maintaining a consistent surface resistivity (10^{11} ohms/square) over extended periods in both normal (55% RH) and dry (13% RH) environments.

This easy-to-use product is suitable for any washable static control surface and is designed to be used full-strength. 3M Remover 8001 comes in a handy refillable 1 quart spray bottle. It is a clear, colorless, homogenous, water-based liquid that contains detergents, conditioners, and other cleaning additives, and has a fresh, clean scent.

Simply spray on Mark Remover 8001 and wipe it off with a clean cloth or sponge. For difficult spots or stains, agitation of the surface with a brush or sponge may be helpful. Scotch-Brite™ Soft Scour!™ blue scrub sponges are suggested for this purpose.
